The End of Section 4 Support?

Public consultation on the new draft Immigration and Citizenship Bill

In July of this year, the Government published its Draft Immigration and Citizenship Bill, which is intended to replace all previous immigration legislation. When it becomes law, the Bill will have a huge impact on the lives of all immigrants, asylum seekers and refugees in the UK. Among other 'simplifying' measures, the Bill will change the way asylum seekers can access housing and welfare support ('NASS' support).

The formal consultation process on the asylum support system is due to run from mid October to late November of this year. The outcome of the consultation will influence the asylum support provisions in the new Immigration and Citizenship Bill.

UKBA appears to be concerned that a lot of money is spent on supporting refused asylum seekers and is under pressure to spend less on asylum support in general. Although the overall amount spent on supporting asylum seekers has halved in the last six years (from over £1 billion to £485 million), over 56% of their budget now goes on supporting 'refused' asylum seekers.

Women's Project

ASAP's project prioritising destitute asylum seeking women

April of this year, ASAP Women's Project has been targeting the needs of destitute female asylum seekers who have been victims of sexual violence. For the past 6 months we have been trying to ensure that we reach those women who need our help.

Since April 2008, ASAP has represented 25 women at the Asylum Support Tribunal and advised a further 8 women on their appeal hearings. 94 calls to our Advice Line since April have involved female asylum seekers. Most of the women we helped were destitute and many were also suffering from physical or mental health problems. Several had young children and were surviving on food parcels and small amounts of money they received from local charities.

Case study – a young woman with a serious medical problem:

ASAP represented a young woman with serious health problems in her appeal against the UKBA decision not to give her support. The woman had a serious and extremely rare illness and was pregnant with her second child. UKBA refused to support her stating that her illness is not serious enough and that she is fit enough to leave the UK.

The client was attending a hospital in London where she was receiving specialist care from a consultant. The hospital had provided a letter stating that they had never met a patient with a combination of these problems and stressed that she required expert care and treatment that was only available at this hospital.

At the appeal hearing, the Adjudicator allowed her appeal and granted her support on the grounds that it was unreasonable for someone with her condition to be expected to leave the UK due to the risk international travel would pose to her health.

After the appeal, based on the medical evidence, ASAP tried to ensure that the woman was provided with accommodation in London as she clearly met UKBA's own criteria for accommodation in London. Despite the strength of the medical evidence and many phonecalls and letters, it took UKBA almost four weeks to house her and her child in London.

Improvements for Asylum Seekers Appealing at the Asylum Support Tribunal

After months of lobbying, ASAP has had some success in getting a fairer deal for asylum seekers appealing to the Asylum Support Tribunal

Extra food entitlements:

UKBA has agreed to provide extra food for asylum seekers who have asylum support appeal hearings and have to stay overnight in a hostel near Croydon. Every year, many asylum seekers travel from regional cities to the Asylum Support Tribunal in Croydon in order to attend their asylum support appeals. Some of them have to stay at the hostel before and/or after their hearing. While UKBA always provided travel vouchers and paid for the hostel accommodation, there was no provision for food apart from breakfast offered at the hostel once a day. As a result, many asylum seekers with no money routinely ended up having no food for almost a whole day. UKBA now provides not just breakfast but dinner and also a lunch pack for a return journey.

Travelling by train:

Asylum seekers with appeal hearings at the AST are now able to travel to East Croydon by train. Under previous UKBA policy, all appellants had to travel to the tribunal by bus, regardless on the length of the journey. This new policy means that many individuals are able to travel home on the same day, and that people with serious health problems are not forced to make long and uncomfortable bus journeys.

Continuation of support

When a person's asylum support is withdrawn, UKBA will continue to provide support if an appeal is lodged with the AST within four days of receiving the letter discontinuing

support. However, the Border Agency were stopping this support if the notice of appeal was given out of time. UKBA has now changed this policy and will now continue to provide support if the late appeal is accepted by the Asylum Support Tribunal.

Our Progress Over the Last 6 Months

Some information on how ASAP has been performing this year

We are now half way through the financial year, and ASAP has is about to publish its Annual Report for 2007-08. Here are some of the things we have been doing since April:

- ASAP's legal advisers represented 79 asylum seekers at the Asylum Support Tribunal.
- They advised a further 29 people at the AST
- 100% of our feedback from appellants at the AST said they were happy with the service and that ASAP helped them understand the process better
- ASAP took 207 calls to our Advice Line, 119 of which concerned Section 4 support
- 162 people attended our training sessions from 75 different organisations
- 93% of our training participants (71 out of 77) said they felt more confident giving advice on Section 4 support following the training

47% of clients represented in their appeal by ASAP where successful. Asylum Support Tribunal statistics show that only 20% of all appeals are successful. The charts on the next page show a breakdown of decisions with an ASAP representative and overall AST decisions

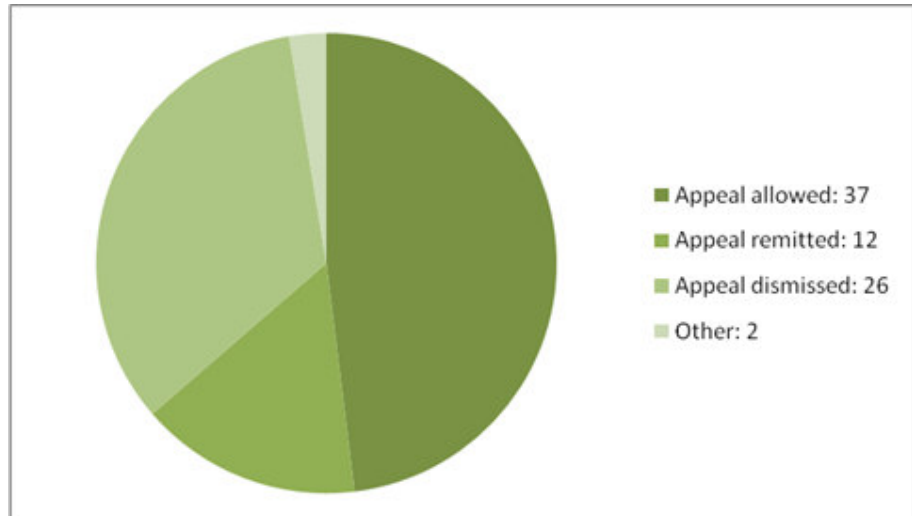
